The meeting was called to order at 8:45am by Gordon E with 10 board members present: Justin H, Christopher D, Keith C, Jason L, Spencer J, Don W, Richard R, Steve C and Jon H (Lambda Lines). Additionally, two meeting trusted servants attended – Guy K and Diane F.

- The meeting began with the trusted servants discussion since they were invited to this meeting. The only trusted servant who attended was Guy K (Diane F joined later).
- Guy K (5:45pm Happy Hour group) asked if the recovery house vans were posing challenges to Lambda and potentially violating our mission statement of being a gay and lesbian clubhouse.
- Overall the consensus was that the situation has improved and recovery house personnel are making donations to the meetings where they weren't in the past.

Previous meeting minutes from June were approved in a motion made by Christopher D, and seconded by Steve C. Motion passed unanimously.

Reports:

Jon H (Lambda Lines):

- Jon brought up content for the next edition of Lambda Lines
- Justin H suggested adding content regarding the upcoming Lambda South Anniversary Dinner
- Still need bios from Spencer J and Jason L
- Jon suggested adding information on free sober events around Fort Lauderdale
- Announce next movie nighty scheduled for 8/22 (confirm with David H)
- Christopher D suggested putting out the request for names of all trusted servants for all meetings
- Don W suggested adding information on how to donate to the Lambda South clubhouse in will and estate planning

Gordon E (President):

• Gordon reiterated the theme for this year's board is to communicate, hence the invitation sent to trusted servants to attend today's meeting

Justin H (Vice President):

- Justin H brought the board up to speed on the anniversary dinner, scheduled for Sunday, 9/27/15. The dinner will be buffet-style this year (no table service)
- Justin H presented menu alternatives for the group top review. The group confirmed the \$79/person New Riverfront Buffet menu for the dinner
- The Riverside hotel charges a \$1500 minimum for the event + 22% service charge
- A deposit of \$1000 is required to hold the venue
- Group asked if the event would be held on the rooftop terrace? Justin will confirm
- Justin is expecting to raise \$3000 from the raffle (and Kenny B has guaranteed that figure)
- Spencer J offered a free estate plan package to be included in the raffle
- Justin H made a motion for the board to support the event up to \$10k total sales, including tickets and raffle. The motion was seconded by Spencer J and passed by a majority vote by those in attendance.
- Justin H suggested selling tickets electronically only (via Wild Apricot). Christopher D suggested that we should still sell paper tickets to insure we reach everyone and have the highest possible sales. Justin H said he would print 100 tickets.
- Justin H suggested we reach out to Aaron C to MC the event. Justin will look into this.

Christopher D (Treasurer):

- Christopher reported the following balances in his treasurer's report:
 - o Checking (Operating Account): \$31,920.85 as of July 5, 2015
 - o Reserves (Reserve Account): \$10,181.72 as of 6/30/2015
 - o Total cash on hand: \$42,102.57
 - o Total income was up by \$500 from May 2015 (\$5,512.44 vs. \$5,020.44) led by higher contributions and group collections.
- Richard R made a motion to accept the treasurer's report, which was seconded by Jason L. The motion passed unanimously.

Steve C (Assistant Treasurer):

- Membership total is 124 people
- Jason will plan a new membership drive to coincide with the anniversary dinner
- Jason L made a motion to discount the membership during the anniversary dinner. The motion was seconded by Keith C and passed with by a majority of attendees.

Don W (Operations):

- Reported that the night-light is out. Reported that the ladies room light was out. We need bulbs!
- Don said the clubhouse needs a major house cleaning. There are old files and other items that are taking up vital storage space and they need to go
- The board plans to stay after the meeting on 8/9 for a cleanup brigade

Spencer J (Building Manager):

- Reaching out to electricians and A/C people and not getting calls back.
- A/C person is MIA. No response
- Diane F (secretary sober sisters meeting) works for Moss Construction and will come up with some reliable contacts for Spencer

Keith C (Asst. Building Manager):

- Keith C expressed that he is not happy with the condition of the patio and that it's in constant need to cleaning
- Keith C will reach out to the person who refinished the floors for a remedy
